## What is GYBN?

- aims to raise global awareness among young people for the values of Biodiversity
- global network of youth organizations and individuals working on Biodiversity
- Faciliate action plans for youth advocacy and empowerment
- Build capacity to enable youth to be change agents on both the national and international level
- Coordination platform for youth participation in the CBDprocess

## History of GYBN

 idea to establish international youth network on Biodiversity has been discussed since at least COP9

 several international youth conferences on Biodiversity took place between 2008 and 2010

 at CBD COP10 representatives of all these groups finally met and agreed to create GYBN






2nd International Youth Symposium on Biodiversity, Canada, August 2009

## **History of GYBN**

- Interim Steering Committee coordinated establishment process from 2010 to 2012
- GYBN Kick-Off Meeting in Berlin in August 2012:
  - 40 representatives of youth organizations from 20 countries
  - funded by Germany, hosted by NAJU
  - → Adoption of GYBN Statute and establishment of the network






#### **GYBN Members**

- Launch of GYBN membership registration process in mid-May 2013
  - 410 registered individual members from 86 countries
  - 51 member organizations from 30 countries, representing 340.000 members
  - 800 subscribers of our GYBN mailing list
  - over 2.100 fans on our facebook page





#### **GYBN Achievements**

- Coordination of Youth Participation at COP11
- Governments of Sweden, Spain and Colombia invited GYBN to represent youth at Key-Biodiversity Meetings in 2012 and 2013
- Initiation of Partnership with Korean youth for COP12
- Coordination of fundraising activities for COP12
- First Youth Delegation to CBD intersessional meeting SBSTTA-18 and WGRI-5 2014
- Coordination of Youth Participation at COP12
- Coordination of Youth Input to IUCN World Parks Congress



- June: GYBN delegation to WGRI-5 and SBSTTA-18 in Montreal
  - 1 Side Event together with CBD Alliance
  - 8 Interventions
  - Proposal to develop a Strategy on Youth Engagement
  - meeting with Korea, government confirms willingness to fund us





## Youth Participation at COP12

- 36 youth delegates at COP12 in Korea
- Youth Capacity-Building Seminar
- 2 Interventions so far
- 5 Youth Side Events





#### Why YOUTH?

- Half of the world's population is under 30
- Decision taken today directly affect the lives of youth
- We are the future decision-makers



Many youth worldwide are active in environmental activism, conservation, research, policy-making



#### **Youth Awareness**

- Awareness and understanding of Biodiversity is low
  - only very few studies have analyzed youth awareness so far, no comprehensive study exists
  - Biodiversity loss only an issue of concern for 48% of children and youth (Forsa 2007)
  - One out of seven children cannot explain what the term "endangered species" means (SCBD 2010)

#### Youth Awarenesss

- In a survey conducted in 2010 10.000 children and youth were asked about their perception of nature
  - watching TV and playing Computer Games a priority for 40%
  - Saving the environment only a priority for 4%
- •2009 study conducted in the UK with 1.500 children
  - 30% of those interviewed couldn't tell the difference between a wasp and a bee



- 1. → Encourages · Parties · and · other · governments · to · include · youth · fully · in · all · relevant processes, · and · specifically · in · the · implementation · of · the · Strategic · Plan · for · Biodiversity · 2011-2020, · national · biodiversity · strategies · and · action · plans · as · activities · under · the · United · Nations · Decade · for Biodiversity; · and · ¶
- 2. → Invites · Parties · to · continue · to · provide · support · for · youth · initiatives · that · support · the · three · objectives · of · the · Convention , · such · as · the · Global · Youth · Biodiversity · Network · ¶
- 1) Acknowledgement of the importance of youth participation
- 2) Encourages parties to fully involve youth in all relevant processes
- 3) Invites parties to continue to provide support for youth initiatives that support the three objectives of the conventions

## **Participation Figures**

- Host country is usually represented in large numbers
  - → But number of host country youth typically decreases at next COP: e.g. 20 japanese youth at COP10, only 1 at COP11


 Key Magediverse countries (e.g. Colombia, Malaysia etc.) were not or poorly represented at COP11

 Lack of youth delegates from countries of both the Global South and the North

#### **Participation Figures**

- Various World Regions remain underrepresented
  - Europe (except of Germany at COP11, 1 at COP10)
  - Africa (2 at COP11, 2 at COP10)
  - South-America (1 at COP11, 1 at COP10)
  - Central America (0 at COP11, 1 at COP10)
  - Western Asia (none)
  - Eastern Asia (2 at COP11, 20 at COP10)
  - Australia (none)

## **Main Challenges**

- Many youth organizations and young people in the world are involved in on-ground nature conservation projects
- Youth organizations are mostly active on the local or national level
- Very few engage on the international level due to:
  - Lack of dedicated funding for youth participation in Biodiversity governance
  - lack of knowledge about the importance of the CBD and how to participate effectively
