THIRD MEETING OF THE COP BUREAU - NAIROBI

The COP-9 Bureau held its third meeting on 13 February 2009 at the United Nations Office in Nairobi, Kenya, back to back with the 25th session of the Governing Council / Global Ministerial Environment Forum (GC/GMEF) of the United Nations Environment Programme (UNEP). The representative of the COP 9 President, Jochen Flasbarth, reviewed the list of actions agreed upon at the Bureau's second meeting. Ahmed Djoghlaf, CBD Executive Secretary, briefed the meeting on the status of availability of financial resources for the implementation of COP-9 decisions and meetings. The ABS Co-Chairs, Fernando Casas and Timothy Hodges, gave a briefing on developments in relation to the implementation of the Bonn Mandate on access and benefit-sharing. The Bureau also discussed: the revision of the Strategic Plan of the Convention, the preparations for the Eminent Persons Workshop in March 2009, the preparations for COP-10 meeting, among other issues. The minutes of the COP Bureau meeting will be made available once finalized on the COP Bureau webpage at http://www.cbd.int/cop-bureau/. It was decided that the next COP Bureau meeting will be held on 30 March 2009, in Paris, France.

The COP Bureau meeting was preceded by an **ABS Workshop** organised for the Bureau members. Some members of the COP Bureau, as well as staff from the CBD Secretariat, also participated in the **technical meeting of the United Nations Environment Management Group** held on 14-15 February 2009 in Nairobi, Kenya.

REGIONAL REAL-TIME ONLINE CONFERENCES ON RISK ASSESSMENT AND RISK MANAGEMENT UNDER CPB

The fourth meeting of the COP-MOP called for the establishment of an Open-ended Online Expert Forum on Risk Assessment and Risk Management and an Ad Hoc Technical Expert Group (AHTEG) on Risk Assessment and Risk Management. The COP-MOP also requested the Executive Secretary to convene ad hoc online discussion groups, two AHTEG meetings and at least one real-time online conference per region prior to each of the two AHTEG meetings. Pursuant to this, regional real-time online conferences were convened by the Secretariat through its Biosafety Clearing-House (BCH). In February, regional real-time online conferences were held: Latin American (3 February), Africa (10 February) and Asia (17 **February).** A number of issues regarding the development of a "roadmap" and additional guidance materials on specific aspects of risk assessment and risk management of LMOs were discussed. ONLINE DISCUSSION FORUM ON ARTICLE 10© 11 FEBRUARY-11 MARCH 2009

In its decision IX/13 A, paragraph 4, the Conference of the Parties requests the Executive Secretary to continue to compile case studies, analyze and report on work concerning related provisions, focusing on Article 10(c), and to provide advice to the Working Group on Article 8(j) at its sixth meeting on how this related provision may be further advanced and implemented as a priority. In order to assist the Executive Secretary in the preparation of advice for the next meeting of the Working Group, an Online Discussion Forum on Article 10(c) is currently being held from 11 February to 11 March 2009 through the Traditional Knowledge Information Portal of the Convention's website.

All National Focal Points, indigenous and local community organizations, non-governmental organizations, academics and other interested parties are invited to participate in the conference.

25TH SESSION OF THE UNEP GOVERNING COUNCIL / GLOBAL MINISTERIAL ENVIRONMENT FORUM—NAIROBI

The CBD Executive Secretary participated in the 25th session of the United Nations Environment Programme Governing Council / Global Ministerial Environment Forum (GC-25/GMEF), held in Nairobi, Kenya from 16-20 February. At the invitation of the UNEP Executive Director and South Africa's Deputy Minister for Environmental Affairs and Tourism, the Executive Secretary also participated in the High-level Gender and Environment Forum held on 15 February. The Executive Secretary also took part in a number of side events in the margins of the GC-25/GMEF, including: "The Green Customs Initiative: Capacity Building for Environmental Security" organized by the Czech Republic; the Ministerial-level roundtable on "Global crisis: national chaos?" - Towards a "green economy"; and the Ministerial-level roundtable on "International Environmental Governance (IEG) -Help or Hindrance?" - IEG from a country perspective. Meetings were also held with the Associate Director and Head of UNI-TAR's Environment Unit, as well as with a number of Environment Ministers. The Executive Secretary also attended a briefing made by the ABS Co-Chairs to the staff of UNEP-DELC and UNEP Regional Directors on the status and process of the regional ABS consultations. A meeting was also held between the three Executive Secretaries of the Rio Conventions and the EU Presidency. A brainstorming session on the post-2010 target organized by UNEP-DELC was held on 15 February. A decision on the International Year of Biodiversity was adopted at the GC-25/GMEF.

The SCBD organized, jointly with UNEP and UNWTO a series of three roundtables on Sustainable Tourism, which took place on 27 February 2009, during the the Reisepavillion - International Fair for Alternative Travel in Munich, Germany (from 26 February to 2 March 2009). The first panel discussed "International initiatives on sustainable tourism", the second panel explored "Standards and certification for sustainable tourism", and the third panel, chaired by the Secretariat, presented: "Biodiversity and development – a training programme for sustainable tourism". SCBD's involvement in the Munich Fair is part of the Biodiversity and Development unit's activities, and is in line with its objective to develop a Biodiversity and Development training set on CBD's thematic development areas (forest, agriculture, water, etc). The first module of the training set will present a 'Toolkit of Good Practices' on Tourism for Development and Nature Conservation. The draft tourism guidelines training manual was presented in Munich for peer review and will be launched in the upcoming months.

FIRST MEETING OF THE FRIENDS OF THE CO-CHAIRS ON LIABILITY AND REDRESS UNDER THE CARTAGENA PROTOCOL ON **BIOSAFETY**

The First Meeting of the Friends of the Co-Chairs on Liability and Redress under the Cartagena Protocol on Biosafety was held from 23 to 27 February 2009 at the Ministry of Foreign Affairs in Mexico City, Mexico. The meeting further negotiated international rules and procedures on liability and redress for damage resulting from transboundary movements of living modified organisms (LMOs) in the context of the Protocol, based on the proposed operational texts on liability and redress, contained in the Annex to decision BS-IV/12 on Liability and Redress. The participants produced a draft text for a supplementary protocol on liability and redress to the Biosafety Protocol, which will serve as basis for further consideration at the second meeting of the Group of Friends of the Co-Chairs, scheduled to be held in early 2010 in Kuala Lumpur, Malaysia.

VISITORS THIS MONTH

On 2 February, the CBD Executive Secretary welcomed the visit of the Mr. David Schindel, Executive Secretary of Consortium for the Barcode of Life (CBOL). A presentation on the work of CBOL was made. Senior staff from the Québec Ministre de la Culture, des Communications et de la Condition feminine, Ms. Josée Blackburn and Mr. Denis Lemieux visited on 4 February and had an opportunity to meet with the CBD Executive Secretary and relevant staff to discuss partnership with Québec and sustainable development. Ms. Eva Spehn, Executive Director of the Global Mountain Biodiversity **Assessment (GMBA)**, University of Basel, visited the Secretariat on 5 February to discuss collaboration with CBD. Ms. Roslyn Slawner of the Hart Resources met with the CBD Executive Secretary on 6 February on staff team-building activities. On 17 February, a **staff member** from the Scientific and Technical Advisory Panel of the Global Environment Forum (GEF-STAP) visited the Secretariat and delivered a presentation on the STAP, its mandate, composition and modality of work, and its relevance to the work of CBD. A delegation from the New Zealand High Commission in Ottawa was welcomed by the CBD Executive Secretary on 23 February. Issues discussed include: the Strategic Plan of the Convention, invasive alien species, and preparations for COP-10, among other things.

CAPACITY DEVELOPMENT WORKSHOP FOR THE PACIFIC ON NBSAPS, THE MAINSTREAMING OF BIODIVERSITY AND THE INTEGRATION OF CLIMATE CHANGE

From 2 to 6 February more than 30 participants from the Pacific Region, from governments, regional organizations, NGOs and local communities, gathered to share experiences and build capacity on the development, implementation and review of NBSAPS and the mainstreaming of biodiversity into broader national, local and regional policies and strategies. Participants underlined the importance of facilitating stakeholder participation in NBSAPs and emphasized the need to ensure that mainstreaming occurs in practice, rather than just on paper. Participants highlighted the urgent need to enhance the integration of climate change considerations within NBSAPs and appreciated training in tools including application of the ecosystem approach, strategic environmental assessments and risk management techniques, and communication education and public awareness.

BUSINESS AND BIODIVERSITY

On 4 February 2009 the SCBD hosted the first teleconference of the Steering Committee for *the Business and the 2010 Biodiversity Challenge meeting* to be held in Asia in November 2009. Sixteen members representing government, NGOs, and the private sector met to decide on a venue and discuss potential agenda items. It was decided that the meeting should be held in Jakarta, Indonesia. While many agenda topics were suggested, all agreed that the meeting should be broken down by sector so as to facilitate exchange of experiences and identify the way forward for increased integration of biodiversity considerations in each sector. The Steering Committee will meet again at the end of March to finalise the meeting agenda and identify potential speakers.

YOUTH OUTREACH

February was a busy month for youth outreach. On 18 February, the CBD Secretariat took part in "Biodiversity Matters", a youth conference for the awareness and engagement on actions for biodiversity. The conference was organized by the Protect Our Water and Environmental Resource (P.O.W.E.R.) in Georgetown, Ontario, Canada. Over 180 secondary students, teachers, administrators, community organization representatives and members of the general public participated in several CBD Secretariat presentations on biodiversity, youth involvement in the Convention process (e.g. *The Green Wave*), the International Year of Biodiversity and other CBD initiatives. From 23 and 26 February, four presentations were delivered to English and French college students in the Montreal area. These presentations focused on the 2009 theme for the International Day for Biological Diversity – Invasive Alien Species.
