

ACCESION OF SOMALIA TO THE CON-VENTION ON BIOLOGICAL DIVERSITY

The Secretariat of the Convention on Biological Diversity welcomed the accession of Somalia to the Convention on Biological

Diversity (CBD), to become the 193rd Party to the Convention on Biological Diversity on 10 December 2009. With its numerous efforts to secure the accession to the Convention by the few countries that are not yet parties, the Secretariat hopes that by COP-10 in Nagoya, the Convention will become universal by welcoming the two remaining Governments that have yet to ratify the Convention. FIRST MEETING OF THE STEERING COMMITTEE FOR SOUTH-SOUTH COOPERATION ON BIODI-**VERSITY**

In preparation for COP 10, at which it is expected that decision IX/25 will be complemented by the adoption of the Multi-Year Plan of Action (MYPoA), the G-77 established a Steering Committee on SSC on biodiversity, with the presence of past and future G-77 chairs, key Parties in the CBD and the secretariats of both organizations. On 29 October, the Secretariat convened the first meeting of the Steering Committee for SSC, to further advance the multi-year plan of action and to prepare for the South-South Cooperation Forum on Biodiversity for Development, scheduled to be held on 18 October 2010, at the margins of the tenth meeting of the Conference of the Parties to the CBD. The committee defined a process for consultations and validation of the Plan, inter alia, through the organization of another expert meeting in Kampala, Uganda, 31 May to 2 June 2010, and through the SSC Forum in Nagoya, on 18 October 2010.

GERMAN LAUNCH OF THE LOGO FOR THE INTERNATIONAL YEAR OF BIODIVERSITY

On 24 October, on the occasion of the UN Day celebrations of the City of Bonn, Germany, the logo and slogan for the 2010 United Nations International Year of Biodiversity (IYB) were unveiled at the old town hall of Bonn. At the reception hosted by Mr. Jürgen Nimptsch (Mayor of the City of Bonn), Ms. Flavia Pansieri (UNV Executive Coordinator) presented the logo and its slogan standing for the crucial role that biodiversity plays in supporting all life on Earth, including our own. The reception was attended by representatives of the diplomatic corps accredited in Bonn, the German Federal Environment Ministry (BMU), the German Federal Ministry for Economic Cooperation and Development (BMZ), other UN agencies based in Bonn, as well as by representatives of the City of Bonn and relevant organizations.

EXPERT WORKSHOP ON SCIENTIFIC AND TECHNI-CAL GUIDANCE ON THE USE OF BIOGEOGRAPHIC CLASSIFICATION SYSTEMS AND IDENTIFICATION OF MARINE AREAS BEYOND NATIONAL JURISDICTION IN NEED OF PROTECTION

Pursuant to decision IX/20, paragraph 19, the Executive Secretary organized, with financial support from the Governments of Canada and Germany, an Expert Workshop on Scientific and Technical Guidance on the Use of Biogeographic Classification Systems and Identification of Marine Areas beyond National Jurisdiction in Need of Protection, in Ottawa, Canada, from 29 September to 2 October 2009.

The Workshop was attended by experts from Argentina, Bulgaria, Canada, China, Comoros, Estonia, France, Germany, Guatemala, Japan, Mexico, Norway, Philippines, Portugal, Senegal, and Turkmenistan. The experts were selected among experts nominated by Governments in consultation with the Bureau of the Conference of the Parties. The Workshop was also attended by a member of the Bureau of the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA) and by resource persons provided by Australia, Brazil and IUCN. Experts/observers from the following other Governments, United Nations bodies, specialized agencies, and other bodies attended: the Oceanic and Atmospheric Administration (NOAA) of the United States of America, the United Nations Division of Ocean Affairs and the Law of the Sea (UNDOALOS), the Food and Agriculture Organization of the United Nations (FAO), the International Seabed Authority (ISA), the Intergovernmental Oceanographic Commission of the United Nations Educational, Scientific and Cultural Organization (IOC / UNESCO), United Nations Environment Programme - World Conservation Monitoring Centre (UNEP – WCMC), United Nations Environment Programme / Mediterranean Action Plan (UNEP / MAP), United Nations University – Institute of Advanced Studies eas (IUCN / WCPA), Census of Marine Life, Ocean Biogeographic Information System (OBIS), BirdLife International, Greenpeace International, and World Ocean Coun-

Key outcomes of the workshop include: (i) review and synthesis of progress on the identification of areas beyond national jurisdiction, which meet the scientific criteria in annex I to decision IX/20; (ii) scientific guidance on the use and further development of biogeographic classification systems; (iii) scientific guidance on the identification of marine areas beyond national jurisdiction, which meet the scientific criteria in annex I to decision IX/20; (iv) recommendations on capacity building for identifying ecologically or biologically significant marine areas (EBSAs) and biogeographic classification system; and (v) recommendations on data and analysis for identifying EBSAs and bio- on all of the issues that were discussed. geographic classification systems.

COOPERATION WITH WAZA



An agreement was signed between the Secretariat and the World Association of Zoos and Aquariums (WAZA) on 5 October. The objective of the agreement is to provide a framework for cooperation between the two organizations. Potential areas of collaboration, but are not limited to, in-

clude: raising public awareness about the importance of biodiversity; coordinated efforts to mark and celebrate the IYB; promoting the role of WAZA members in ex situ and in situ conservation. The agreement was signed in the margins of the WAZA Congress and 64th Annual WAZA Meeting in Saint Louis, Missouri. A keynote address on the "Conservation and Sustainable use of Biodiversity from Z to A: Zoos & Aquariums & the Conven-

tion on Biological Diversity 2010 & Beyond" was presented at the plenary.

FIFTH MEETING OF THE INFORMAL ADVISORY COM-MITTEE OF THE BIOSAFETY CLEARING-HOUSE

The fifth meeting of the Informal Advisory Committee of the Biosafety Clearing-House (BCH-IAC) was held in Montreal on 19-21 October 2009. In accordance with decisions made by the Parties, the BCH-IAC meets annually to provide guidance to the Secretariat with respect to the resolution of technical issues associated with the ongoing development of the BCH. This meeting was attended by (UNU - IAS), IUCN World Commission on Protected Ar- experts selected from Belize, China, the European Community, Liberia, Madagascar, Peru, Serbia, Slovenia, Tajikistan and Uruguav and representatives from the U.S. Department of State, CBD Alliance, Global Industry Coalition (GIC) and the United Nations Environment Programme (UNEP) also participated. The agenda of the meeting addressed the following issues: (i) Recent changes in the BCH; (ii) BCH forum, activities and tools; (iii) Online Tools for Statistical Analysis and Graphic Representations of Data; (iv) Study of users and potential users of the BCH; (v) Draft Strategic Plan of the Cartagena Protocol focusing on the BCH component; (vi) Future developments and challenges; and (vii) Status of the UNEP-GEF BCH project extension. The participants congratulated the Secretariat for the progress achieved and the quality of the improvements made and provided very helpful recommendations

THE AFRICA AND ASIA PACIFIC REGIONAL WORKSHOPS ON THE REVIEW OF PROGRESS AND CAPACITY-BUILDING FOR THE IMPLEMENTATION OF THE PROGRAMME OF WORK ON PROTECTED AREAS UNDER THE CONVENTION ON BIOLOGICAL DIVERSITY

In pursuance of the request from the Conference of the Parties, contained in paragraph 25 of decision IX/18, the Executive Secretary, with the generous financial assistance of the European Commission, the Governments of Belgium, Canada, the Czech Republic, the Netherlands and in collaboration with the Governments of Côte d'Ivoire, India and the PoWPA Friends Consortium, organized Africa and Asia Pacific regional workshops on the review of progress and capacity-building for the implementation of the programme of work on protected areas, held from 6 to 9 October 2009 in Grand Bassam, Côte d'Ivoire and from 12 to 15 October 2009 in Dehradun, India, respectively.

The objectives of the workshops were: (i) to strengthen the skills and knowledge of protected area functionaries and others who implement the programme of work through an exchange of experiences, sharing of tools, available resources and capacity-building in two aspects of the programme of work on protected areas: (a) integration of protected areas into wider land and seascapes; and (b) governance; (ii) to review progress made in implementation of the programme of work on protected areas at subregional and regional levels, including identification of constraints and opportunities to promote implementation; and (iii) inputs to the fourteenth meeting of the Subsidiary Body on Scientific, Technical and Technological Advice, to be held in May 2010 on the in-depth review of the programme of work on protected areas, including proposing ways and means for strengthening the implementation and the programme of work on protected areas post-2010.

The African regional workshop was attended by 38 government-nominated experts from Angola, Algeria, Botswana, Benin, Burkina Faso, Burundi, Cape Verde, Central African Republic, Comoros, Congo, Côte d'Ivoire, Djibouti, Egypt, Ethiopia, Gambia, Guinea, Kenya, Liberia, Libya, Madagascar, Malawi, Mali, Mauritania, Mauritius, Morocco, Mozambique, Niger, Nigeria, Rwanda, Sao Tome and Principe, Senegal, Seychelles, Sudan, Swaziland, Togo, Tunisia, Uganda, Zambia. It was also attended by two representatives of indigenous and local communities and a representative of International Collective in Support of Fish Workers and Simba Maasai Outreach Organisation. The World Conservation Monitoring Centre of UNEP, the IUCN World Commission on Protected Areas, IUCN Regional Office for West and Central Africa, Birdlife International, WWF, The Nature Conservancy, UNDP-GEF provided resource persons.

The Asia Pacific workshop was attended by 25 government-nominated experts from Cambodia, China, Fiji, India, Iraq, Japan, Kuwait, Kyrgyzstan, Lao, Maldives, Marshall Islands, Micronesia, Nepal, Niue, Palau, Papua New Guinea, Philippines, Samoa, Saudi Arabia, Solomon Islands, Syria, Thailand, Timor Leste, Tonga, and Viet Nam. Three representatives from indigenous and local communities, one each from: the Asia Indigenous Peoples Pact Foundation, the Partners



of Community Organizations (PACOS) and from the Mountain Institute also attended the workshop. A representative from IUCN - The World Conservation Union (Lao PDR) and World Commission on Protected Areas–IUCN CSO Nepal (Forest Action), and a representative from the International Collective in Support of Fish Workers also attended the workshop. Birdlife International, Wildlife Conservation Society, The Nature Conservancy, UNDP-GEF, the Wildlife Institute of India and Kalpavriksh, India provided resource persons.

Both the workshops reviewed progress made in the implementation of the PoWPA at sub-regional and regional levels and provided in puts on the in depth review of PoWPA.



REGIONAL WORKSHOP FOR LATIN AMERICA AND THE CARIBBEAN ON WAYS AND MEANS TO PROMOTE THE SUSTAINABLE PRODUCTION AND USE OF BIOFUELS, 28-30 SEPTEMBER, 2009, LOUVEIRA, SÃO PAULO, BRAZIL

Hosted by the Government of the Federated Republic of Brazil, this first of a series of regional workshops on ways and means to promote the sustainable production and use of biofuels, held in response to decision IX/2, was attended by 24 participants from 14 countries. Delegates heard presentations on country experiences from Brazil, Colombia, Cuba, Mexico and Saint Lucia, which focused on the experiences with different crops for the production of bioethanol and biodiesel, approaches to zoning agricultural land to minimize land use conflicts, and strategic environmental assessments of the sector. Participants also benefited from the invitation by UNICA - the Brazilian Sugarcane Industry Association - to visit the São João Sugar Mill in Araras and see large-scale mechanized sugarcane production which demonstrated the progressive elimination of the burning in sugarcane fields; the preservation of riparian forests; the protection of water springs located in areas where crops are cultivated and the recovery of vegetation around them; combating erosion; reutilization of water from the industrial phase of biofuel production; optimizing recycling and promoting the reuse of residues. The meeting emphasized the importance of framing the discussion on biofuels within the context of sustainable development and its three pillars and,



based on national experiences, listed available approaches and tools to minimize negative effects on biodiversity. Noting the different stages of biofuel development within the region there was also recognition of the potential for regional cooperation among Latin American and Caribbean countries towards the sustainable production and use of biofuels. The workshop report will serve as a point of reference for forthcoming regional meetings for Asia and the Pacific and for Africa.

EXPERT WORKSHOP ON THE REMOVAL AND MITIGATION OF PER-VERSE, AND THE PROMOTION OF POSITIVE, INCENTIVE MEASURES, 6-8 OCTOBER 2009, PARIS, FRANCE

The Executive Secretary convened an international expert workshop on the removal or mitigation of perverse, and the promotion of positive, incentive measures. Hosted by the United Nations Environment Programme at its premises in Paris, France, and financially supported by the government of Spain, the meeting took place from 6-8 October 2009. As requested by the Conference of the Parties at its ninth meeting, the 28 government-nominated national experts and representatives from international and non-governmental organizations and initiatives exchanged and analysed information, including casestudies on, good practices for, and lessons learned from, concrete and practical experiences in removing or mitigating perverse incentives and in promoting positive incentive measures, and identified a limited number of good-practice cases from different regions of the world. The report of the group will be considered by the next meeting of the Subsidiary Body on Scientific, Technical and Technological Advice and reviewed by the Conference of the Parties at its tenth meeting.

SUB-WORKING GROUP ON THE ROADMAP FOR RISK ASSESSMENT, 12-14 OCTOBER 2009, THE HAGUE, NETHERLANDS

The meeting of the Sub-Working Group on the Roadmap for Risk Assessment of the Ad Hoc Technical Expert Group on Risk Assessment took place from 12 to 14 October 2009 in The Hague, The Netherlands. The meeting, attended by thirteen participants from Parties and six observers, was aimed at the further development of the draft Roadmap and establishing a process to test its usefulness and completeness as a tool for facilitating risk assessment of living modified organisms (LMOs). Substantial progress was made in the drafting of the Roadmap and a process was established to test the usefulness and completeness of the Roadmap.

The Congress, organized by the City of Toronto, Green Roofs for Healthy Cities (GRHC) and World Green Infrastructure Network (WGIN) brought together business representatives, urban planners and developers, architects, landscapers, cities'representatives, NGOs and international infrastructure networks and organizations. A statement by the Executive Secretary, entitled 'Promoting Biodiversity in Cities of Today and Tomorrow' was released on 20 October (http://www.cbd.int/doc/speech/2009/sp-2009-10-20toronto-en.pdf) and the Secretariat made a presentation (http://www.cbd.int/doc/groups/cities/citeis-alive-2009-10-20-scbd-en.pdf). The Secretariat introduced the work of the CBD on Cities and Biodiversity as well as IYB, and demonstrated the strategic importance of integrating biodiversity in infrastructure development projects, as stressed by paragraph 4 of Decision IX/28 on Cities and Local Authorities, which invites Parties, other Governments (...) engaged in projects that include infrastructure development for cities and local authorities, to integrate biodiversity considerations into those projects. Infrastructure (water, waste, energy, transportation) is the largest financial pipeline linking national and local authorities, with key implications for biodiversity and environment. The congress created an opportunity for the Secretariat, participants and organizers to explore ways to collaborate for the Curitiba meeting on Cities and Biodiversity in January 2010 and in preparation for the City Biodiversity Summit (tentative name) to take place at the margins of COP 10, on 24-26 October 2010.
