#### ANNOTATIONS TO THE PROVISIONAL AGENDA

The Bureau of the Conference of Parties serving as the meeting of Parties to the Cartagena Protocol on Biosafety (COP-MOP), consistent with Article 29, paragraph 3 of the Cartagena Protocol, will meet to examine issues related to the draft Strategic Plan of the Cartagena Protocol and the Proposed Framework for the second Assessment and Review process. The meeting will be held in Cali, Colombia.

#### ITEM 1: OPENING OF THE MEETING

2. The meeting will be opened by the representative of the President of the Conference of Parties serving as the meeting of Parties to the Cartagena Protocol on Biosafety (COP-MOP). The Executive Secretary will make brief opening remarks.

#### ITEM 2: ADOPTION OF THE AGENDA

3. The Bureau will be invited to adopt the provisional agenda prepared by the Executive Secretary (document UNEP/CBD/COP-MOP/Bur/2010/1/1).

# ITEM 3: DRAFT STRATEGIC PLAN (2011 -2020) OF THE CARTAGENA PROTOCOL ON BIOSAFETY

4. Under this item, the Bureau will have before it, the updated version of the draft elements of the Strategic Plan (2001-2020) (UNEP/CBD/BS/COP-MOP/5/16) for its comments and further action.

5. Under this item, the Secretariat will introduce the report of the proposed framework for second assessment and review process of the Protocol (UNEP/CBD/BS/COP-MOP/5/15). The report discussed the issues of the nature and scope of the assessment, and the possible elements of a methodology for the

second evaluation of effectiveness of the Protocol. The report further discussed the issues of timing, scope, data-gathering/sources of information, data analysis, integrating reporting, effectiveness evaluation and the strategic planning process in the CPB and indicators of the process. The Bureau will be invited to examine the recommendations and conclusions of the report for its comments.
