STATUS OF PREPARATIONS FOR THE TWELFTH AND THIRTEENTH MEETINGS OF THE SUBSIDIARY BODY ON SCIENTIFIC, TECHNICAL AND TECHNOLOGICAL ADVICE

Note by the Executive Secretary

- 1. The provisional agendas for the twelfth and thirteenth meetings of the Subsidiary Body on Scientific, Technical and Technological Advice (SBSTTA) were approved at its eleventh meeting in November 2005 (UNEP/CBD/COP/8/3, annex II).
- 2. At its eighth meeting, in March 2006, the Conference of the Parties requested SBSTTA to carry out a number of additional activities prior to the ninth meeting of the Conference of the Parties, in May 2008, namely:
- (a) A survey of the linkages between the priority actions of the programme of work on island biodiversity and all other thematic work programmes and cross-cutting issues (decision VIII/1);
- (b) Proposals on the incorporation of climate-change adaptation considerations into the programme of work on dry and sub-humid lands and a compilation of existing information on the status and trends of dry and sub-humid lands biodiversity (decision VIII/2);
- (c) A synthesis of progress in relation to the implementation of elements of the programme of work on the biological diversity of inland water ecosystems and a review of technical requirements in view of ongoing and planned activities of the Scientific and Technical Review Panel of the Ramsar Convention (decision VIII/20);
- (d) An analysis of options for preventing and mitigating the impacts of some activities to selected seabed habitats (decision VIII/22);
- (e) Draft guidance on how to integrate relevant climate change impacts and response activities into the programmes of work of the Convention (decision VIII/30).

- 3. In order to include the additional requests made by the Conference of the Parties, the Executive Secretary, in consultation with the SBSTTA Bureau through a teleconference held on 22 September 2006, revised the provisional agendas in light of the decisions of the Conference of the Parties. During the teleconference, the SBSTTA Bureau members discussed also how to handle more efficiently the main themes of the meetings in order to promote scientific discussions. They emphasized, in particular, the need for keynote and panel presentations to stimulate such discussions.
- 4. The provisional agenda for the twelfth meeting of SBSTTA is annexed hereto, and the annotations thereto will soon be posted on the Secretariat's website. The twelfth meeting will be held from 2 to 6 July 2007, at the headquarters of the United Nations Educational, Scientific and Cultural Organization (UNESCO) in Paris, and will be followed by the meeting of the Open-ended Working Group on Review of Implementation of the Convention.
- 5. The thirteenth meeting of SBSTTA will take place from 18 to 22 February 2008, at the headquarters of the Food and Agriculture Organization of the United Nations (FAO) in Rome and will be preceded by the second meeting of the Open-ended Working Group on Protected Areas.
- 6. Both SBSTTA meetings represent an opportunity to strengthen cooperation between the Convention on Biological Diversity and UNESCO and FAO, bearing in mind that the main themes for review in each SBSTTA meeting also fall within the realm of these organizations.
