7. VISAS

Persons entering Burkina Faso will need to have a valid passport and required visas. Participants who are not able to obtain visas beforehand should ensure that they have their letter of invitation to the workshop on hand and cash to pay for the visa (50 000 Francs CFA will be sufficient however the amount varies according to the country of origin).

8. HEALTH REQUIREMENTS

An international certificate of vaccination for yellow fever is required upon arrival from all countries. Recommended vaccinations include Hepatitis A and B, typhoid, polio, meningococcal diseases and rabies. Participants are also advised to take antimalarial drugs (Chemoprophylaxis) and to use insect repellent sprays and creams.

11. CREDIT CARDS

American Express, Diners Club, MasterCard and Visa are widely accepted in Burina Faso, as are international traveller's cheques in Stirling Pounds, Euro, US Dollars.

12. OFFICIAL LANGUAGE

French is the official language of Burkina Faso.
