# Specific Objectives



- Facilitate national implementation of Strategic Plan for Biodiversity 2011-2020, by assisting Parties to develop *national biodiversity targets*;
- Assist in *reviewing, updating, revising and implementing NBSAPs*, to serve as an effective tool for mainstreaming biodiversity into broader national policies; and
- To stimulate early actions to implement other Aichi-Nagoya outcomes, in particular, the *Nagoya Protocol on Access and Benefit Sharing*, and the *Nagoya-Kuala Lumpur Supplementary Protocol on Liability and Redress to the Cartagena Protocol on Biosafety*

# Expected Outcomes



- By 2012, adoption of national targets in line with the Strategic Plan;
- By 2014, new updated and revised NBSAPs, adopted as policy instruments, and fully integrated into national planning processes;
- Early entry into force of the Nagoya Protocol on Access and Benefit Sharing and the Nagoya-Kuala Lumpur Supplementary Protocol on Liability and Redress to the Cartagena Protocol on Biosafety;
- Effective implementation of other COP-10 decisions in the context of NBSAPs;
- Effective sharing of knowledge, practices and technologies in support of the implementation of the Convention.



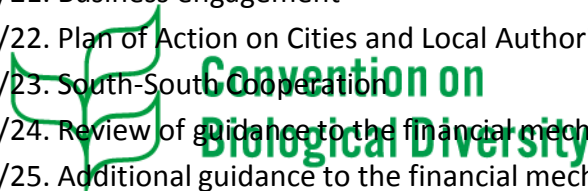

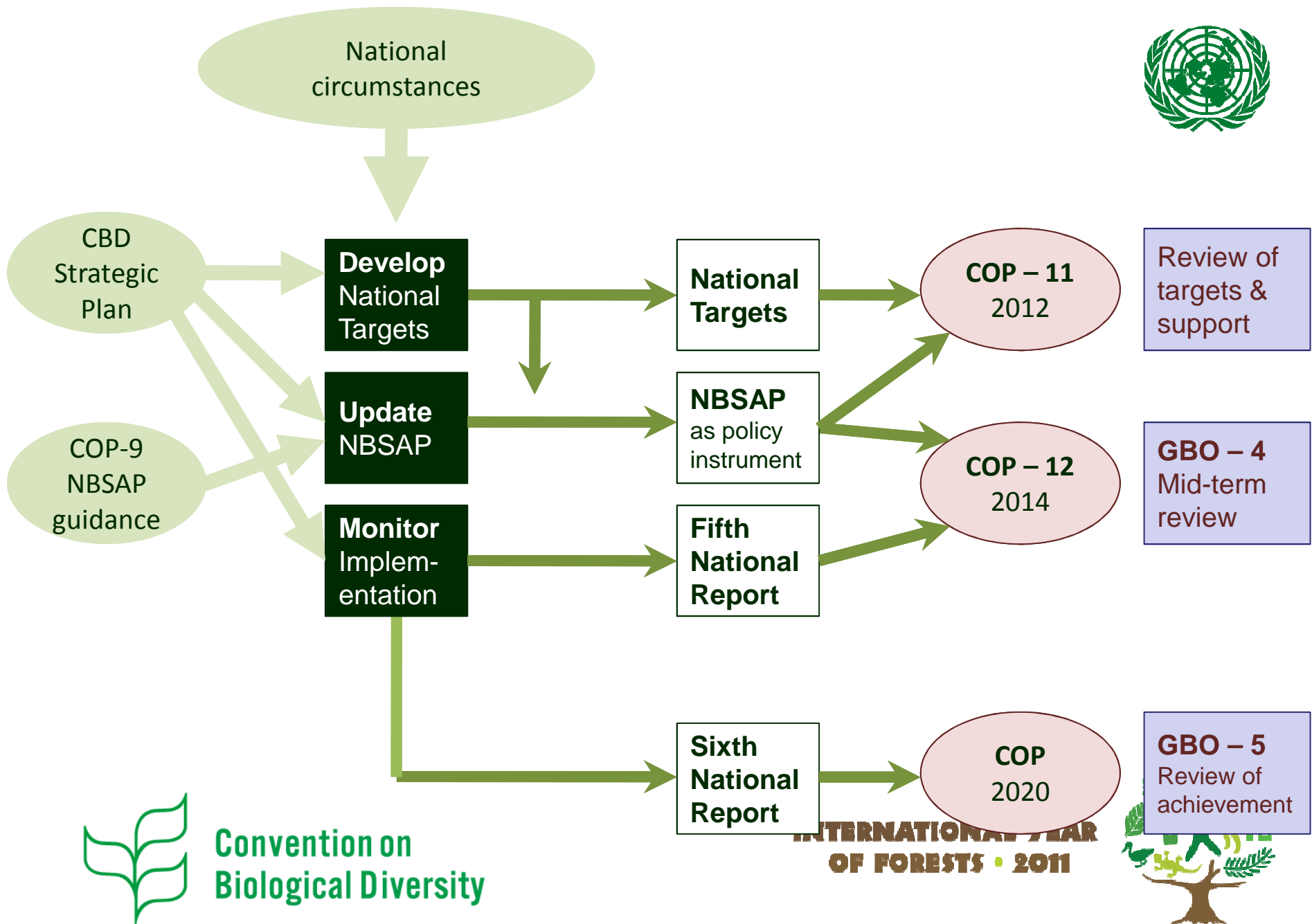

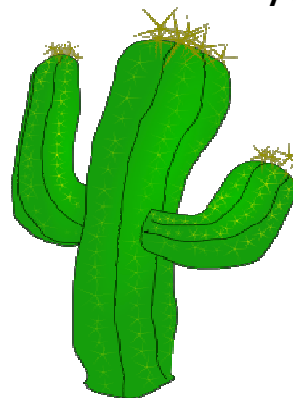
