A Brief Outline

The Clearing-House Mechanism (CHM) aims to promote and facilitate technical and scientific cobetween Contracting operation Parties of the Convention on Biological **Diversity** and participating partners. It will play an important role in the implementation of the three objectives of the Convention. The CHM will also facilitate the global and exchange of access to information on biodiversity, its sustainable use and the equitable sharing of its benefits. Article 18(3) of the Convention on Biological Diversity is the basis for the development of the CHM.

#### CHM main characteristics:

- Compatible with national capacities
- Needs-driven
- Decentralized in nature
- Provides access to information
- Supports the decisionmaking process
- · Involves the private sector

## THE CHM PILOT PHASE

The CHM is in its pilot phase, which will last until the end of 1998. Its guiding principles emphasize that the CHM should be neutral. cost-effective, efficient and have a independent transparent and structure. It should use printed and electronic means of communication. The CHM will gradually developed in response to clear and identified demands. It also has to promote and facilitate the access to technology and capacity building. For more information visit:

### SBSTTA 3 Recommendations

At the last meeting of the Subsidiary Body on Scientific, Technical and Technological Advice of the Convention of September 1997, the following CHM recommendations were made to the COP:

**1**. Provide guidance to the GEF for financial support (a) for the pilot phase as an enabling activity, (b) to strengthen national

biodiversity information systems and networks.

- **2.** Request Parties to develop examples of best practices in the use of the CHM .
- **3.** Request Governments, bilateral and multilateral funding institutions to provide funding to further develop and implement the CHM.
- **4.** Invite Parties to provide information on funding sources using the CHM.
- **5.** Invite Parties and partners to use the CHM logo.
- **6.** Secretariat (SCBD) to facilitate access to the CHM network and to make information available on the Secretariat's work.
- **7.** SCBD to provide a list-server with all the CHM focal points and partners.
- **8.** SCBD to improve synergies with other conventions and initiatives
- **9.** CHM to be practical, innovative, decentralized and creative. And based on a network of partners; use a simple structure and be designed to continue beyond the pilot phase.
- **10.** Pursue an independent review of the pilot phase and present it at SBSTTA 4.

# INFORMAL ADVISORY COMMITTEE

The Informal Advisory Committee (IAC) of the CHM was established at the last Conference of the Parties to the Convention. The IAC will guide the development of the CHM's pilot phase and will also ensure that all the members of the Convention can participate in this The committee was pilot phase. established by the Executive Secretary of the Convention in a transparent manner and requested the nomination of two delegates per geographic region. The following countries are now part of the IAC: Burkina Faso, Canada, Colombia, Germany, Indonesia, Jamaica. Malaysia, Malawi. Poland and Russian Federation. In addition, BIN 21 (Biodiversity Information Network 21), **Biodiversity** Conservation Information System (BCIS), the Inter-American Biodiversity Information Network (IABIN), and the Organization of Economic Commerce and Development (OECD) Working Group on Bioinformatics observers to this committee.

Dr. Calestous Juma, Executive Secretary of the Convention, will covene the IAC during COP 4.

### **REGIONAL WORKSHOPS**

As requested by the last Conference of the Parties, the Secretariat of the Convention organized four regional workshops on the CHM to identify information needs and priorities at national and regional levels. workshops focused on information content, information structure and capacity building. The recommendations proposed focussed on information content, information structure and capacity builling and they will be considered during COP 4 negotiations. Four regional workshops were held for:

- Latin America and the Caribbean (13-15 October, 1997 in Cartagena, Colombia)
- Central and Eastern Europe (27-29 October, 1997 in Gödöllö, Hungary)
- **Asia** (3-5 December, 1997 in Kuala Lumpur, Malaysia)

• **Africa** in Nairobi, Kenya (5-7 March 1998).

These workshops were convened thanks to the special additional voluntary contributions made by the Governments of Australia, Austria, Canada, Germany, the Republic of Korea, Japan, the Netherlands and the UK.
