Further comments

- 1. Case studies have not been used because there are no specific case studies available for our area as yet.
- 2. Insufficient co-ordination between different agencies has been a limiting factor. For example, introduction of certain exotic species was encouraged by some agencies as part of vegetative recovery programs, and many of these (such as *Prosopis juliflora*) have become invasives beyond the areas of cultivation.

Accidental or deliberate introductions of marine species (e.g. species of seaweeds via tanker ballast water, or species associated with aquaculture) may become a serious threat in both the Red Sea and the Arabian Gulf.
