International Biodiversity Year 2010 Report of Activities

The European Centre for Environmental Research and Training (EKePEK), located in Athens, Greece, participated to the International Year of Biodiversity from the very beginning. During this year, EKePEK organized several activities in the framework of the IYB. Here is a report of EKePEK's activities in the framework of the International Year of Biodiversity:

- Participation in HEL.BIO.NET. The Hellenic Biodiversity Network constitutes the Greek contribution to European Lifewatch Network Programme (under the ESFRI Roadmap).
- Copenhagen 2009. The environment in the middle of an international crisis. EKePEK organized a conference on the aftermath of the COP 15, which took place in Copenhagen in December 2009. EKePEK's conference took place in Athens, on the 26-27th January 2010.
- Europe and the Environment: The case of Climate Change and Biodiversity in the 21st century. The first week of October (1-7 October 2010), EKEPEK organized an Interdisciplinary Postgraduate Summer Training Program, in the island of Kithira. The participants attended classes concerning the protection and preservation of biodiversity and watched relevant documentaries. They also had the chance to go path trekking and visit several landscapes of the island. This Course is a part of the seminar series that our Centre organizes since 2004, and have been recognized as Good Practice under the 10 Years Framework of Programmes on Sustainable Consumption and Production Patterns of the United Nations Economic Commission for Europe¹.
- Postgraduate program assignments. EKePEK supports scientifically the postgraduate program "Environmental Governance and Sustainable Development". During the spring semester the students were given scientific assignments for the course "Special Issues of International Environmental Law" concerning the protection and preservation of biodiversity, using the IYB logo at the front page of each assignment.
