National Aarhus center of the Republic of Kazakhstan is created in June, 2009 by the Ministry of environmental protection of the Republic of Kazakhstan on the basis of Republic State Enterprise «Informational and analytical center of environmental protection» with a view of realization Aarhus convention on access to the information, public participation in decision-making and access to justice in environmental matters.

Aarhus center is guided by: Aarhus Convention; Ecological code of the Republic of Kazakhstan; Concept of ecological safety of the Republic of Kazakhstan, Concept of transition of the Republic of Kazakhstan to sustainable development, programs and strategies of the Republic of Kazakhstan and Ministry of environmental protection of the Republic of Kazakhstan.

Center supports web-portal www.aarhus.kz, information-consulting service is functioning, State fund of ecological information is conducted, electronic database of legal documents in the field of environmental protection and nature usage «EcoInfoPravo» is being supported, at training courses are studied NGO, mass media and public organizations representatives.
